## Personal Investments

As a non-profit organization (NPO), Christoa Ministries, INC (CM) cannot sell shares in the company or pay personal dividends. We have developed a way for you to invest personally in our first ministry office location: Willcox, AZ.

When you buy an NPO “share,” you can select a church to receive NPO “dividends.” Since the financial part of Christoa Ministries seeks to help fund churches and pastors around the world, the payments of NPO “dividends” fits within our ministry purpose and 501(c)(3) status. Each NPO share you buy earns .001% of our profit at this location for the year for the church of your choice as long as the church of your choice qualifies to receive funds from CM.

If you do not have a church in mind, you can donate your shares to a church we already sponsor (viewable on the missions page at [christoa.com](http://christoa.com)) or reinvest in Christoa Ministries, INC.

## Christoa Ministries, INC; NPO Investment Agreement

When you purchase NPO shares from Christoa Ministries, INC for this location, you agree to these terms and conditions.

### **Payment of dividends**

All dividends will be paid to churches or other non-profit organizations based on their qualifications under those listed in the Christoa Ministries, INC; bylaws. Churches and NPOs that do not meet the qualifications will not be paid dividends. Those dividends will, instead, be paid to Christoa Ministries mission churches around the world.

### **Dissolution of shares and payment of dividends**

Shares and dividends will never be dissolved unless this particular Christoa Ministries location ceases ministry to the community and stops collecting donations.

### **Transfer of dividends**

Dividends can be transferred by the individual who holds the shares at any time. In the case that a church or NPO dissolves or stops meeting the qualification provided by the Christoa Ministries bylaws, dividends will automatically transfer to a mission church of Christoa Ministries. They can be transferred to a new church or NPO at any time by the shareholder.

### **Transfer of shares**

NPO shares are non-transferrable.

### **Perks**

Perks are non-transferrable and the venue-rental agreement must be followed.
